5. Parking stickers must be placed in the lower left corner of the rear window of vehicles (guest permits should hang from the rearview mirror).
6. Village Mews vehicle identification stickers and/or guest passes will NOT be distributed to nor used by any individual for the purpose of parking within the community to avoid the commuter parking lots for the trains or buses.
